REGULAR COUNCIL MEETING MINUTES
Monday, May 5, 2025

The regular meeting of the Garrison City Council was held on Monday, May 5, 2025, at 6:00 pm. The meeting was held at the Garrison Public Library. Mayor Flickinger presided. - Mayor Flickinger opened the public hearing concerning the City of Garrison's Budget Amendment for Fiscal Year 2025. Being there were no comments, and no objections or written comments filed, Mayor Flickinger closed the public hearing.

Whereupon Mayor Flickinger declared the following duly adopted: “Resolution to Approve the Contract for Law Enforcement Services with the Benton County Sheriff for Fiscal Year 2025-2026” – passed and approved this 5th day of May 2025.
