REGULAR COUNCIL MEETING MINUTES  
Monday, June 2, 2025

The regular meeting of the Garrison City Council was held on Monday, June 2, 2025, at 6:00 pm. The meeting was held at the Garrison Public Library. Mayor Flickinger presided. - Kearns moved to approve the agenda, seconded by Trimble. Ayes: All. Nays: None. Motion carried.
- Mayor Flickinger opened the public hearing concerning the City of Garrison's Code of Ordinances. Being there were no comments, and no objections or written comments filed, Mayor Flickinger closed the public hearing.
- Lindsey moved to approve the consent agenda, seconded by Decker. Ayes: All. Nays: None. Motion carried.

  - Council discussed the changes that need to be made for the fireworks ordinance.
  - Lindsey introduced and moved to accept the 1<sup>st</sup> reading of **Ordinance 382 – An Ordinance Adopting the Code of Ordinances of the City of Garrison, Iowa**, seconded by Kearns. Roll Call Vote: Ayes: Rommann, Lindsey, Decker, Kearns, Trimble. Nays: None. Motion carried.
    - Trimble moved to suspend the rule requiring that an ordinance be voted on for passage at two council meetings prior to this meeting be suspended with respect to **Ordinance 382**, seconded by Lindsey. Roll Call Vote: Ayes: Rommann, Lindsey, Decker, Kearns, Trimble. Nays: None. Motion carried.

- Decker moved to pass and adopt **Ordinance 382 – An Ordinance Adopting the Code of Ordinances of the City of Garrison, Iowa**, seconded by Rommann. Roll Call Vote: Ayes: Rommann, Lindsey, Decker, Kearns, Trimble. Nays: None. Motion carried.
- **Ordinance 382** is declared and enacted.
- Sewer rates were discussed and will need to be raised at July meeting.
- City will check with attorney as to what is needed to hire a nuisance mowing contractor.
- Someone will be hired to do the corner sidewalks on Oak St.
