REGULAR COUNCIL MEETING MINUTES
Monday, July 7, 2025

The regular meeting of the Garrison City Council was held on Monday, July 7, 2025, at 6:00 pm. The meeting was held at the Garrison Public Library. Mayor Flickinger presided. Council members present: Al Lindsey, Doug Kearns, Bob Decker, Tina Rommann and Marvin Trimble. Absent: None. City Clerk, Angela Dague recorded the minutes.

- Trimble moved to approve the agenda, seconded by Rommann. Ayes: All. Nays: None. Motion carried.
- Requested hearing - Bruce Gardner
 - Gardner presented his case to the Council.
 - Lindsey moved to have the city remove the items and assess to taxes, seconded by Rommann.
 - After discussion Lindsey and Rommann rescinded their original motion and second. Kearns then moved to approve that the items be moved to the garage within one week to store until original owner can pick up, seconded by Lindsey. Ayes: All. Nays: None. Motion carried.
- Decker moved to approve the consent agenda, seconded by Kearns. Ayes: All. Nays: None. Motion carried.

- Council heard department reports.

- Business Items:
 - Trimble moved to approve Resolution to set Public Hearing date for Proposed Vacation and Disposal of Property for August 4, 2025 @ 6:00 pm, seconded by Rommann. Ayes: Rommann, Lindsey, Trimble, Decker. Nays: Kearns. Motion carried.
 - No action taken on clean-up day until we have more information from Kluesner on dates, what they will or will not pick up.
 - Lindsey moved to table the motion to approved line painting bid until we get other bids, seconded by Trimble. Ayes: All. Nays: None. Motion carried.
 - Lindsey introduced and moved to accept the 1st reading of **Ordinance 385 – An Ordinance Amending the Code of Ordinances of the City of Garrison, Iowa, by Amending Provisions Pertaining to Sewer Charges**, seconded by Decker. Roll Call Vote: Ayes: Rommann, Lindsey, Decker, Kearns, Trimble. Nays: None. Motion carried.

- Kearns moved to suspend the rule requiring that an ordinance be voted on for passage at two council meetings prior to this meeting be suspended with respect to **Ordinance 385**, seconded by Trimble. Roll Call Vote: Ayes: Rommann, Lindsey, Decker, Kearns, Trimble. Nays: None. Motion carried.
- Rommann moved to pass and adopt **Ordinance 385 – An Ordinance Amending the Code of Ordinances of the City of Garrison, Iowa, by Amending Provisions Pertaining to Sewer Charges**, seconded by Rommann. Roll Call Vote: Ayes: Rommann, Lindsey, Decker, Kearns, Trimble. Nays: None. Motion carried.
- **Ordinance 385** is declared and enacted.
- It should be noted that there was an error on the agenda as to the number of the ordinance and it was corrected.

Decker moved to adjourn the meeting, seconded by Trimble. Ayes: All. Nays: None. Motion carried. There being no further business before the council, Mayor Flickinger, adjourned the meeting.
