REGULAR COUNCIL MEETING MINUTES
Monday, January 5, 2026

The Garrison City Council held its regular meeting on Monday, January 5, 2026, at 6:00 p.m. The meeting was held at the Garrison Public Library. Mayor Flickinger presided. Council members present: Al Lindsey, Doug Kearns, Tina Rommann, and Marvin Trimble. Absent: Bob Decker. City Clerk, Angela Dague recorded the minutes.

- Lindsey moved to approve the agenda, seconded by Trimble. Ayes: All. Nays: None. Motion carried.
- Public hearing – Proposal to enter into a Water Revenue Loan and Disbursement Agreement
 - Mayor Flickinger opened the public hearing concerning the proposal to enter into a Water Revenue Loan and Disbursement Agreement and to borrow money thereunder in a principal amount not to exceed \$211,500. After comments, and with no objections or written comments filed, Mayor Flickinger closed the public hearing.

- Kearns moved to approve the Memorandum of Understanding Between the Iowa Department of Revenue and the City of Garrison Regarding State SetOff Program, seconded by Rommann. Roll Call Vote: Ayes: Rommann, Lindsey, Trimble, Decker, Kearns. Nays: None. Motion carried.
- Trimble moved to approve Resolution Setting the Compensation of the City of Garrison Employees for Fiscal Year 2026-27, seconded by Rommann. Roll Call Vote: Ayes: Rommann, Lindsey, Trimble, Decker, Kearns. Nays: None. Motion carried.
- Council will not pardon the lien on 301 W Maple St

- A budget meeting will be held January 28 @ 6 pm with Mayor, Trimble, Kearns and Clerk.
