REGULAR COUNCIL MEETING MINUTES
Monday, December 5, 2022

The regular meeting of the Garrison City Council was held Monday December 5, 2022, at 6 pm. The meeting was held at the Garrison Public Library. Mayor Flickinger presided. Council members present: Al Lindsey, Tina Rommann, Robert Decker, and Doug Kearns. Absent: Marvin Trimble. City Clerk, Angela Dague recorded the minutes.

- Decker moved to approve the agenda, seconded by Kearns. Ayes: All. Nays: None. Motion carried.
- Lindsey moved to approve the consent agenda, with added claims, seconded by Decker. Ayes: All. Nays: None. Motion carried.

- Departments gave reports/comments
 - Mayor – A map was created of junk vehicles around town
 - Public Safety – report attached
 - Attorney – report attached
 - Maintenance/Roads – Found backhoe leak, applying for work zone package, snow plow needs to be put on, need to think ahead to a new city truck or look into a new transmisson
 - Public Works – daily water #s were high, found the leak, the city does not have lead lines – have to fill out lead line inventory
 - BC Development – Holiday Party – December 14 in Van Horne
 - Sesquicentennial – Plans are well underway for a Friday night and Saturday event.
 - Park – Leak in toilet was stopped. Will replace toilet and valve in the spring.
 - Library – December concert had 90+ people, Soup with Santa will be December 15, working on fund raising for new sign.
 - Fire Dept. – looking for new recruits, Christmas party is 17th, Auxiliary will by flag poles and want to donate to sign.
 - Administrative – IPERS compliance went well, attended budget workshop
- Old Business
 - Decker introduced and moved to accept the 1st reading of **Ordinance 379 – An Ordinance Amending the Code of Ordinances of the City of Garrison, IA, By Amending Provisions Pertaining to Water Rates**, seconded by Kearns. Roll Call Vote: Ayes: Rommann, Lindsey, Decker, Kearns. Nays: None. Absent: Trimble. Motion carried.
 - Rommann moved to suspend the rule requiring tht an ordinance be voted on for passage at two council meetings prior to this meeting be suspended with respect to **Ordinance 379**, seconded by Lindsey. Roll Call Vote: Ayes: Rommann, Lindsey, Decker, Kearns. Nays: None. Absent: Trimble. Motion carried.
 - Rommann moved to pass and adopt **Ordinance 379 – An Ordinance Amending the Code of Ordinances of the City of Garrison, IA, By Amending Provisions Pertaining to**

Water Rates, seconded by Kearns. Roll Call Vote: Ayes: Rommann, Lindsey, Decker, Kearns. Nays: None. Absent: Trimble. Motion carried.

- **Ordinance 379** is declared and enacted.

- Mayor Flickinger provided a map of junk vehicles. The town will be divided into thirds. We will start with the northeast side, south east side and then the west. Junk accumulation and downed buildings will be addressed also.

- **New Business:**

- Discussion on what to do with snow removal and maintenance until Gary returns. Also discussed a contingency plan if the snow plow breaks down.
- There will be no code meeting in December.
