REGULAR COUNCIL MEETING MINUTES  
Monday, March 6, 2023

The regular meeting of the Garrison City Council was held Monday March 6, 2023, at 6 pm. The meeting was held at the Garrison Public Library. Mayor Flickinger presided. Council members present: Al Lindsey, Marvin Trimble, Robert Decker, and Doug Kearns. Absent: Tina Rommann. City Clerk, Angela Dague recorded the minutes.

- Decker moved to approve the agenda, seconded by Kearns. Ayes: All. Nays: None. Motion carried.
- Trimble moved to approve the consent agenda, with added claims, seconded by Lindsey. Ayes: All. Nays: None. Motion carried.

  - Maintenance/Roads – Scott Monroe requested rock hauled to the alley behind his house. Maintenance will get with him so he knows how much to purchase. Mowers have been serviced and clean up has started in maintenance building. There are a couple of stop signs that need to go up. Some discussion of items that needed to be done per safety audit.
  - Public Safety – no report given

  - Public Works – there have been no alarms at the lift station. A light needs to be installed there.

  - Administrative – Website was supposed to be launched on March 1. It hasn’t yet.

  - Discussion on mud messes around the streets and potholes posscaused by heavy vehicles by J&R Sanitation, and mud messes at old gym.

    - The driveway needs some attention.
    - Discussion on who fills the potholes
    - Discussion on citizens using it as a thru street. It is not. Cameras were discussed and better signage needs to be put in place.
  - Code meeting will be March 20 @ 6 pm.
    - Randy from Prairie will attend
